- C. Vote on Budgeting Reimbursements
  - a. Reimbursement for personal checked bag on Florida trip. When Ryan Samn, Student Life Assistant purchased the low cost tickets, it was already disclosed to students they would need to buy their own bag up front and then they could vote later to get the bag price reimbursed. Rolo made a motion to approve each student officer who attended the Florida conference a \$60 reimbursement as long as the original receipts for each \$30 bag were included. 2nded by Jose. With a vote of 16 yes, 0 no and 0 abstain, the proposal is approved. The ASSC will reimburse the 10 officers + Alvin for the checked bags they paid for at \$60 each.
  - ASSC owes VPSS office \$279.48 for payment to half of one of the Florida conference hotel rooms since Ryan's Procard had declined that night due to double charges and an error the hotel made. Motion to approve made by Jose, 2nded by Rolo. Votes: 16 yes, 0 no, 0 abstain, motion passes. Ryan will complete paperwork to reimburse VPSS office and Golda Margate's Procard for \$279.48 from our ASSC Conference account.

The Center for Student Life has not yet paid for the invoice but the ASSC wants to host a holiday party for their student leaders and select staff members like Mary Escobar and Jackie Flores to thank them for their support for ASSC. The ASSC wanted the food catered by Sky Dragon and the quote was around \$800. Vote to approve an order of food for Holiday Party + supplies as needed: Hadasa moved to approve, 2nded by Lali: votes: 16 yes, 0 no and 0 abstain.
