IV. Welcome and Introduction

Committee members introduced themselves with their name, position, area they represent, and way in which they've stayed grounded during the pandemic, racial reckoning, and record-breaking wildfires.

V. External and Internal Measures of Institutional Effectiveness

Members provided input in the chat on and then shared their interpretation of the following quote by Seymour and Bourgois (2018) in the *Institutional Effectiveness Fieldbook*: "In a very narrow sense, institutional effectiveness might be seen as the act of measuring performance against stated goals and missions at all levels of an institution... But one can distinguish between the event of declaring something effective and the process that is ultimately required to reach that conclusion."

Members remarked that IE is a continuous process; that it may involve determining if the assessment itself is appropriate; and that how the goal is implemented is just as important as the assessment.

To get an introduction of the external and internal metrics that the College uses to assess its institutional effectiveness, members completed zoom poll questions on the following topics, and Karen provided additional information about each:

- A. Purpose of accreditation, CCCCCO Vision for Success goals
- B. College Mission, Strategic Goals, and College Scorecard



Approved Minutes

1. Member discussion was focused on how these provide a sense of direction for the College.

C. SLO Assessment

1. Member discussion dwelled on how SLO assessment is required by the ACCJC but that no one chose it as an incentive to engage in SLO assessment. Members preferred how it's used to spark discussion with colleagues, for instance about core knowledge, skills and attitudes from a course or program.
2. Additional discussion was on what happens if an area doesn't fulfill the SLO.

1. Member discussion dwelled on how program review may be changed this year, including how it may fall under IEC charge.

2. Analyze the impact of the College's responses to COVID – 19 conditions
3. Engage in a dialogue about the Information Literacy ISLO results in partnership with librarians
4. Strengthen understanding of SLOs and assessment
5. If given purview over program review, review IEC membership and committee practices; the templates; which standard data everyone should have to evaluate their program; how to provide training; how to give feedback.
