II. Briefly describe any major changes to the Division or Programs' purview and functions during the past year.

We have had two significant changes over the last year, first we will be ending the Massage Therapy Certificate and our affiliation with the California Massage Therapy Council at the end of this academic year. Second, in October, 2021 the state changed the total hour requirements for the Cosmetology, Esthetician and Barbering Programs from 1600 to 1000 hours effective January 1<sup>st</sup>, 2022.

### III. Briefly describe the major challenges and achievements for your Division over the past year.

The major challenge over the last year was the response to COVID and the transitions related to the ever-changing regulations that programs in the division faced both from the District as well as outside organization regulations. In terms of achievements, our Cosmetology department revamped all of their program requirements and curriculum, the program was also nominated for the program excellence award via the Academic Senate. Our Early Childhood Apprenticeship Program was awarded a \$500,000 grant from the state as well as a \$40,000 grant from the Silicon Valley Community Foundation. The Bay Area Entrepreneur Center was awarded and implemented a \$325,000 in grant funds from the San Bruno Community Foundation to provide microgrants and assistance to San Bruno businesses struggling with the impacts of COVID 19.

1. The Division will be taking a look at the certificates and degrees existing within each department and assessing each's relative success in terms of numbers of awards. 2. The Division will continue the work interrupted by the pandemic in developing 2-3 schedule plans for each department.
