The Center for Student Life and Leadership Development aids individuals and student organizations in the planning, management and evaluation of programs and organizational activities towards address various students needs. The Center for Student Life and Leadership Development has been able to reach its goals for the following:

- Continued development and evaluation of PSLO's
- Continued expansion of SOCC training through social media and online resources
- Collaborative creation, development and evaluation of the Student Leadership and Equity Summit and Leadership Academy
- Collaboration with Service Learning Community of Practice team with Community Day of Action projects May of 2018 and April of 2019 and further planning on the implementation of Service Learning Model at Skyline College.
- Evaluation of Advisor survey results

The members of the department have been participants in the college redesign process and have helped to ensure that the student voice was also included.

Throughout these processes, we have had the opportunity to begin the collaborative process with other constituents that will help ensure the best use of resources as we move forward as a college and enable us to create an innovative and effective program.

The Center for Student Life and Leadership Development has begun an update of the departments Leadership Development Plan. We continue to develop and expand the training for student organizations and their advisors. The CSLLD has collected information from club advisors and continue to research best practices to develop a more robust training program for advisors and clubs. The following are suggestion for expansion of the training for the Student Organizations and Clubs Council and their advisors.

- Continued Expansion of ASSC and SOCC training
- Creating a Student Organization Leadership Retreat / Leadership Institute
- Advisor trainings using digital resources/programs to connect with students



### **II.B.** Analysis: Program Environment

#### Narrative

The Center for Student Life and Leadership Development is currently in the process of updating Leadership Development Plan as part of the College Redesign.

In addition, High Impact Practices such as service learning and civic engagement should involve the CSLLD staff. The Director is currently engaged in the Service Learning Community of Practice and assisting with the development of the program.

The Student Leadership and Equity Summit / Leadership Academies was created and implemented by former Director of Student Development – Amory Cariadus, the TRiO Director – Michael Stokes and the Director of the Promise Program – Ellen Murray, for the ASSC and other clubs during the 2018- 2019 academic year. The series provided an opportunity for students throughout SMCCCD to increase their understanding of equity and further develop their leadership skills. The team's evaluation process consisted of traditional feedback surveys from student participants and a focus group for those who completed the series. The 2018-2019 series was designed for current student leaders and student employees but the sessions for 2019-2020 will be open to all students who are registered at Skyline College.

However, there have been two events that have affected the sessions for 2019-2020. The first instance is the transition from former director Amory Cariadus to, at them time, interim manager Alvin Gubatina. In this transition – Amory's knowledge and vision for this project was lost while Alvin's, then, interim role led him to play a more supportive role in assisting Michael and Ellen with their vision for the project in the Spring.

After Alvin secured the permanent position and was planning with Michael and Ellen on the Spring programming – COVID19 happened. COVID19 essentially wiped out all campus programming for the Spring term.

Additional training for student representatives will be needed and plans for future expansion to revitalization of leadership development programs, Service Learning Programs, and a certificate program will require additional manpower and training time. We continue to review distribution of duties and other staffing options (interns and graduate assistants) to help with this issue.

Online tools, surveys, and event planning curriculum have been developed by Alvin Gubatina to help train and assist students.

While students have an overall understanding of the SLO and have met the criteria; issues with AD ASTRA and the transitions of on campus staff have caused communication issues between student clubs, ASSC, Center for Student Life and Leadership Development and Administrative services.

Then with COVID19 driving all programming to the virtual space – CSLLD and ASSC have been able to create virtual programming.

This led to better understanding of an individuals' rights in a democratic society, the role of the individual in exercising those rights and advocating for themselves and others.

- Student Equity and Leadership Summit (all students)
- Leadership Academy
- Intercultural Center
- College Lecture Series
- Formal recognition of leadership of students and student groups
- Student Leadership Recognition Ceremony

Develop and expand the training for student organizations and their advisors to include but not limited to

- Expansion of advisor training
- Student led workshops for advisors and other students
- Student Organization Leadership Retreat / Leadership Institute

The CSLLD has had the opportunity to collaborative with other constituents on campus and continues to build partners and connections to ensure the best use of resources as we move forward as a college. This has resulted in a continued expansion and revitalization of leadership development programs and possibly a certificate program and service learning programs in the future which will require additional manpower and training time.

We continue to review distribution of duties and other staffing options (interns and graduate assistants) to help with this issue. Despite these challenges the Center for Student Life and Leadership Development will continue to create



innovative programs. We are committed to providing quality services to students, faculty and staff and continuing our role in the overall enhancement of the campus community.

The Center for Student Life and Leadership Development has been working with the Associated Students of Skyline College to develop their understanding of the following items;

- understanding of the function of the committee
- historical knowledge of the committee
- how to develop mentor relationships with experienced staff, faculty and administrators that are members or chairs of the committees

The CSLLD staff believe that by increasing their knowledge base and their comfort level at committee meetings that the students will continue to increase their level of engagement in the participatory process.

Through informal conversations and check-ins with students, the CSLLD staff believe that we have met this SLO.

One student shared that, "I really enjoy and believe what you (Alvin) and Ryan (student life assistant) have done. I feel like you two prepared us to be active participants while also giving us the room to develop our own leadership."

The CSLLD has done the following to assist the ASSC with their committee assignments:

- ASSC Members are encouraged to create binders to pass on to the next committee representative(s)
- Ensure that all student representatives have access to SharePoint and other technology needed to fully participate in the committee meetings
- Collaboration with Committee Chairs to ensure student representatives attendance and participation
- Review functions of the participatory governance committees as listed in the Skyline College Compendium of Committees with ASSC
- Review responsibilities of committee assignments



**Recommendations:** 

- More training on committee purposes and expectations of student representatives
- Create opportunities for future student representatives to job shadow current student representatives
- Assist with ASSC with further development of mentoring relationship with professional committee members
- Continued Collaboration with Committee Chairs to ensure student representatives are receiving important committee information and any schedule changes

The CSLLD continues to evaluate this PSLO regarding event planning and community engagement. It is anticipated with additional training and tools the members of ASSC and SOCC will be able to effectively meet the goals of the SLO.

While students have an overall understanding of the SLO and have met the criteria; however, development of new calendaring tolls (AD ASTRA) have caused communication issues between student clubs, ASSC, Center for Student Life and Leadership Development and Administrative services. A collaborative team is currently working on a solution to this problem.



We continue to develop and expand the training for student organizations and their advisors. The CSLLD has collected information from club advisors and continue to research best practices to develop a more robust training program for advisors and clubs.
