#### 2. DISCUSSION/ REPORT

#### 2.1. Comprehensive Program Review Update

Adam Windham, Curriculum Committee Co-Chair and Physics Faculty, apprised the Committee of changes to the Comprehensive Program Review (CPR) submission and review process. Beginning in Academic Year 2018/19, CPR will no longer be administered in the Curriculum Committee. Instead, it will possibly be reviewed in Strategic Planning and Allocation of Resources Committee (SPARC) due to: 1) an increase of non-instructional program reviews in the recent years, 2) a connection to institutional planning and resource allocation, which fall under SPARC's purview.

To accommodate a smooth transition, a Comprehensive Program Review Rubric Task Force, a subcommittee of the Institutional Effectiveness Committee (IEC) and member of SPARC, has been formed. Senate, and Zahra Mojtahedi, Planning and Research Analyst. Task Force members are in the process of developing a rubric, which will be piloted this semester with CPRs.

Windham will continue attending the SPARC in Spring 2018 to help ease the transition as well as answer any questions pertaining to CPR.

## 2.2. 2018/19 Budget Update [Added item]

Eloisa Briones provided a brief update pertaining to 2018/19 Budget.

Upon receiving budget from the District, scenarios of budget will be presented to the Committee. The headcount of International Student Program (ISP) has become the driver for budget allocation. Last year, Skyline College projected a higher number of international students to be enrolled at Skyline College, but the actual is lower than projected, thus, the District will take money away from us, which is to expect a reduction in the site allocation for next year.

## 2.3. Educational Master Plan

Skyline College's Education Master Plan expires in 2018 and the College Strategic Plan expired in 2017. Members were divided into groups to align College's strategic goals with District's strategic goals and reviewed the progress of the listed initiatives. Below listed the comments from each group:
