With the shift of hosting CPR to the Strategic Planning and Allocation of Resources Committee (SPARC) starting from Academic Year 2018/19, it is appropriate to approve the recommendation and move forward the APP prompts to the College Governance Council for adoption.

### 2.3. Recommendation to Adopt the Comprehensive Program Review Rubric

The <u>Comprehensive Program Review (CPR) rubric</u> incorporated the suggestions collected from the last SPARC meeting held on March 22, 2018.

Members appreciated the prompts alignment, which are found useful and easier to follow for both the presenters and evaluators. The CPR rubric will be purveyed as a guiding tool for evaluators to provide feedback to the presenting groups on the written submission of CPR.



### 3.1. Comprehensive Program Review (CPR) Implementation

In Spring 2018, the Curriculum Committee has officially handover the authority of hosting Comprehensive Program Review (CPR) to the Strategic Planning and Allocation of Resources Committee (SPARC), and the SPARC will begin reviewing, evaluating, and providing feedback to CPR submissions beginning AY 2018/19. With more non-instructional programs participating in the Comprehensive Program Review, it is befitting to host the CPR by a committee, such as SPARC, where its charge is for college's planning and budget to provide invaluable feedback from representatives of a wide array of areas. Thus, SPARC will be hosting CPR presentations starting in Academic Year 2018/19.

Jacqueline Honda and Karen Wong provided an overview of the CPR process to the Committee. There will be ten comprehensive program review submissions in 2018/19. The CPR implementation is tentatively proposed as below:

- 1. CPR groups will attend a training in May 2018
- 2. The SPARC members will be divided into sub-groups review of 2 assignments of CPR submissions per group. All reviewing, evaluation, and discussion will and can be executed during SPARC meeting time.
- 3. Each group will share their findings with the Committee and pose any questions to the CPR groups.
- 4. CPR groups will meet with the SPARC to address their questions/concerns.
- 5. CPR groups will have a presentation to SPARC and the College
