1. GENERAL FUNCTIONS

1.1. Call to Order

3. DISCUSSION/REPORT

3.1. DCBF Report - SMCCCD FY 2020-2021 Tentative Fund 1 Budget Scenarios [presented by Eloisa Briones]

Eloisa Briones explained the District's budget assumptions for the upcoming years. Budget projections for Fiscal Year (FY) 2020-2021 may not be greatly affected by COVID-19 as property taxes were set in January 2020 and the District's Fund One budget is based primarily on property taxes. However, a projection of decrease in asset values (AV), property taxes income, international student enrollments, and categorical funds from the State are likely to adversely impact FYs 2021-2022 and 2022-2023.

3.2. Skyline College Fund 1 FY 2020-2021 Tentative Budget Scenarios [presented by Eloisa Briones and Paul Cassidy]

Eloisa Briones followed by presenting Skyline College Fund One Tentative Budget scenarios. As discussed above, Skyline College's scenarios estimate an increase to the budget for FY 2020-2021 reflecting in part a correction to budget allocation from previous years, advantageous to Skyline College from the District.

Paul Cassidy acquainted the Committee the changes, practices, and resources needed during and post COVID-19. Updates will continue on regular basis.

Eloisa Briones instructed the members of the Committee to consult their respective constituents with regard to the budget proposal for FY 2020-2021, which would maintain the same budget as FY 2019-2020, and use any increase to fund a COVID-19 response fund to mitigate adverse financial effects in current and future years.
