 - c) The Classified Senate Board will be involved and the leads for the Caring Campus project
 - d) Caring Campus has a proven method for engaging with classified professionals to create a Caring Campus that ensures they are deeply involved in student success.
 - e) It involves deep coaching for classified professionals to increase student connectedness to the college, which leads to student success. A total of 4 coaching sessions that will be 2 hours each.
 - f) The four parts of Caring Campus work are: leadership orientation, on-site coaching visits, ongoing support and a final webinar.

- 5) Committee Updates
 - a) **Scott Mansfield**—(S.E.E.D Committee) Stewardship for Equity, Equal Employment and Diversity Committee
 - i) They are reviewing their membership

 - iii) The committee has to do with overseeing the College's equality in employment opportunities, provide support and assistance to equity and diversity-related projects and activities for employment and enrollment

 - b) Barbara Lamson—(S.P.A.R.C Committee) Strategic Planning and Allocation of Resources Committee
 - i) The S.P.A.R.C Committee voted to put in motion and voted to put the process on hold for 6 months while they review the curriculum to align it with the budget.
 - ii) Deciding on a Comprehensive Program Review (CPR) process. It will start in the fall instead of the spring to be more aligned with the budget process
 - iii) The CPR will happen before the budget is finalized.
 - iv) Curriculum development will go on as scheduled.
 - v) There was a motion at the end of 1st meeting for TRI Chair to get together to figure out an outline of how the CPR review committee will look like moving forward

- c) Grace Beltran—District Participatory Governance Council
 - i) Three board policies being reviewed
 - (1) No smoking anywhere on campus at all three campuses. Making them a smoke free zone.
 - (2) Use of district communication services—students can only be contacted via student email or personal emails. If students approved they can also be contacted via text.
 - (3) Continuation of employment for classified professionals—probation period is not listed on the board policy.
