1.1. Call to Order

3.2. Skyline College Gathering Norms

IEC Tri-Chair Chris Gibson facilitated an introduction to the <u>Gathering Space Norms</u> adopted by College Governance Council (CGC). Committee members were asked to reflect on the most pertinent norms as they relate to IEC in Zoom chat.

3.3. Introduction to the IEC and Your Role

IEC Tri-Chair Ame Maloney presented a deeper introduction to the IEC and



members' roles, beginning with an introduction to Skyline College's <u>integrated</u> planning and resource allocation model at Skyline College.

Tri-Chair Maloney proceeded to introduce members to the role of IEC with respect to comprehensive program review (CPR) (e.g., providing peer support and feedback), and with respect to institutional student learning outcomes (ISLOs) (e.g., reviewing and making recommendations as a committee on ISLOs under revision).

- Piloting new CPR templates and CPR checklists
- Implementing the Improvement Platform to better integrate program review and SLO assessment work
- · Hosting CPR orientation to programs undergoing review
- Shifting to dialogic model for CPR Share Outs entailing poster session and panel discussion, as opposed to previous 10 min presentation format
- Updating ISLOs
- Reviewing and updating College-wide ACCJC metrics.

IEC Goals for 2023-2024 include continuing to refine and support program review processes and revising the last of the five ISLOs, "Citizenship."
