

PROGRAM REVIEW ENHANCEMENT: 2016-17

OVERVIEW

In the Fall of 2016, Skyline College engaged in a collaborative effort to assess and refine the program review process including the instruments utilized in comprehensive program review (CPR), annual program planning (APP), and administrative leadership unit review (ALUR). This work was prompted by the following factors:

- ► Faculty from the Curriculum Committee expressed a desire to streamline and improve upon the existing program review processes.
- ► SPOL, an online planning system, was acquired in 2016 through IEPI grant funds in order "to enhance the planning and resource allocation processes, adopt a technology-driven system with the ability to document, aggregate, and automate program/college-level plan components."
- ▶ PRIE had an interest in working with faculty to build upon the foundation of the existing process and incorporate recommended improvements in the initial implementation of SPOL.
- ► Efforts align with Accreditation Standard I.B.9. which says, in part, "The institution integrates program review, planning, and resource allocation into a comprehensive process that leads to accomplishment of its mission and improvement of institutional effectiveness and academic quality."

WHO WAS INVOLVED?

The dialogue and related work which occurred included faculty, staff, and an administrator who were also serving in roles as chairs, co-chairs, or members of the:

- ▶ Curriculum Committee
- Strategic Planning and Allocation of Resources Committee (SPARC)
- ► Institutional Effectiveness Committee (IEC)
- ▶ Office of Planning, Research, and Institutional Effectiveness (PRIE)

WHAT HAPPENED DURING THE PROCESS?

- Fall 2016 Curriculum Committee representatives reached out to PRIE about program review
- October 2016-January 2017 Meetings were held monthly
 - Identified concerns about current process and forms
 - Determined goals for refining the existing process
 - Suggested potential solutions, verbiage, and other ideas
 - Developed and vetted draft forms to be converted to online version
- October 2016 PRIE reviewed all CPR feedback forms submitted in the last two years
- December 2016-January 2017 Drafts of new CPR, APP, and ALUR forms were translated from the paper version to the online SPOL system
- January 2017 Demo of the draft CPR in SPOL
 - Group provided feedback and suggested minor adjustments to be made prior to forwarding the drafts for review through established governance channels
