# 3.2. HEERF II Institutional Support Expenditure Plan

The Vice President of Administrative Services, Vice President of Instruction, and Vice President of Student Services, provided an update on the Higher Education Emergency Relief Fund (HEERF) II.

Dr. Newin Orante, Vice President of Student Services, shared that student services recovery needs include technology, enrollment recovery, facilities, and support for disproportionately impacted students, which includes support for undocumented students.

Dr. Rolin Moe, Dean of Academic Support and Learning Technologies (ASLT), presented on behalf of Vice President of Instruction, Dr. Jennifer Taylor-Mendoza. Instructional program recovery needs include technology, support for disproportionately impacted students, and professional development.
