1. GENERAL FUNCTIONS

1.1. Call to Order

Lindsey Ayotte called the regular meeting to order at 2:15 p.m.

2. ACTION ITEM(S)

2.1. Approve Agenda

A motion was made by Karen Wong and seconded by Shaun Perisho to approve the December 9, 2021 agenda.

2.2. Approve Minutes

No motion was made nor seconded to approve November 11, 2021 meeting minutes due to lack of quorum at said meeting. A motion was made by Jessica Hurless and seconded by Ingrid Vargas to approve the October 28, 2021 minutes as written. Motion carried unanimously.

2.3. Decision on Modality of Spring 2022 SPARC Meetings

Lindsey Ayotte opened the floor for input from SPARC on committee meeting modality for Spring 2022. Multiple members noted increased flexibility and opportunities to participate with online modality. Allowing for some members to attend in person while others join remotely in the future, when more HyFlex spaces are available on campus, was also discussed.

A motion was made by Joe Morello and seconded by Nancy Kaplan-Biegel for SPARC to continue to meet virtually in the Spring 2022 semester (twelve affirmative votes, one abstention; motion passed).

3. DISCUSSION/REPORT

3.1. SPARCkle Minutes

The SPARCkle minutes' topic for the day was "Share a holiday break fiasco (or 'memory of things going wrong')." Members shared in breakout groups.

3.2. VPA Report on New Positions for FY 2021-22

VPAS Joe Morello reviewed the creation of new positions during the current fiscal year. He described how the Board of Trustees made available to the Colleges \$6.75 million of one-time funding to advance its *Free Community College* initiatives, including Zero-Textbook-Cost (ZTC), Dual Enrollment, and Promise



Scholars Program. In response to proposals submitted by the Colleges in support of those initiatives, Skyline College was awarded \$2.77 million from the Board of Trustees. These proposals included creation of several new positions serving those initiatives, which the VPAS reviewed in detail in conjunction with results from prioritization processes discussed above, and that the currently open positions reflect continuing searches from prior years and a replacement of a departing faculty member.

Additionally, the State of California also made available \$100 million to Community College. Skyline College will receive more than \$616k from this award recurring annually, and which will also be used to hire new full-time faculty and/or convert adjunct faculty to full-time status.

In response to several questions, VPAS Joe Morello provided an overview of the *Free Community College* strategic initiative instituted by the Board of Trustees. He also described a degree of longer-term risk and that the College will be obligated to prioritize support for these roles in future years. However, he emphasized that it will likely be possible to absorb these positions in future years, and that as a result of these initiatives, the College is now well-positioned for a return to pre-pandemic enrollment levels.
