1. GENERAL FUNCTIONS

1.1. Call to Order

Lindsey Ayotte called the regular meeting to order at 2:13 p.m.

2. ACTION ITEM(S)

2.1. Approve Agenda

- 3.1. **SPARCkle Minutes:** The SPARCkle minutes' topic for the day was "What was one thing that you saved up for to buy as a child/growing-up?" Members shared in breakout groups.
- 3.2. Education Master Planning: SMCCCD Strategic Plan Overview:, Dean of PRIE Ingrid Vargas provided an overview of the SMCCCD Strategic Plan that was approved by the Board of Trustees in July 2021. The updated SMCCCD Strategic Plan has four Strategic Goals:

Strategic Goal 1: Develop and strengthen educational offerings, interventions, and support programs that increase student access, success, and completion.

Strategic Goal 2: Establish and expand relationships with school districts, 4-year college partners, community-based organizations and employers to increase higher education attainment and economic mobility in san mateo county.

Strategic Goal 3: Promote innovation and excellence in instruction to support student learning and success.

Strategic Goal 4: Ensure necessary resources are available to implement this strategic



plan through sound fiscal planning and management of allocations. protect community-supported status, and undertake the development of alternative sources of revenue that support educational programs beyond what is available from community and state allocations.

Dean Vargas proceeded to review the Districtwide strategies that cut across all Strategic Goals identified in the 2021-2026 District Strategic Plan. Committee participants were then placed in four break-out groups (one SMCCCD Strategic Goal per group), and asked to review the overall SMCCCD Goals and the specific strategies under their assigned Strategic Goal and to identify examples of work already underway at Skyline College that support of the District goal and strategies, and to discuss what new initiatives might be undertaken to support the Strategic Goal.
