## 4. DISCUSSION/REPORT

#### 4.1. Resource Allocation Task Force Update:

Committee is moving along with tweaks to the existing model. Board subcommittee will consult with Chancellor's cabinet and meet again in February/March.



## 4.2. Review of Draft EMP Strategies and Activities for Public Posting:

Committee chair Ingrid Vargas updated the committee on the remaining steps in the EMP process. During today's SPARC session, members will review the EMP draft in preparation for review by relevant college departments and programs. SPARC members will then present a draft of the EMP during Opening Day and garner community feedback. Through January and February, SPARC reps/PRIE staff will visit constituent groups for an additional opportunity to provide input. In February, SPARC members will collect final feedback from constituents.

Ingrid shared a document with the committee which shows all of the new EMP goals, paired with their respective draft strategies, some of which are newly added. You can view the document <u>here</u>.

New draft strategies that came out of the EMP exercises led by PRIE and SPARC representatives at recent Division meetings included:

- (Goal 2) **Retain Skyline College students** through completion or transfer to a 4-year college
- (Goal 3) **Upgrade educational technology and facilities** to provide Skyline College students with state-of-the-art tools, equipment and spaces for learning
- (Goal 4) **Encourage partnership and collaboration** across programs and services to better serve students
- (Goal 4) Support student and employee wellness and ease workload stress
- (Goal 5) **Leverage grant and private funding opportunities** which align with the College M-V-V, the College Educational Plan and the SMCCCD Strategic Plan

Committee members broke into groups to discuss each goal and corresponding strategies.

Committee members returned from breakout rooms to report their notes for each goal and suggestions for reworking the draft strategies.

- **Goal 1**: Many strategies still felt high-level and generic. Strategies will become clearer with the development of activities for each strategy. Could we include an "ultimate goal?" Have specific, measurable strategies for the short term.
- **Goal 2**: Alternative to strategy B: "Remove barriers and provide tailored support to facilitate student enrollment." Alternative to strategy A: "Develop an understanding of potential students in our surrounding areas."
- Goal 3: Some strategies could be too broad. Could we break down some strategies to



be more specific?

**Goal 4**: "Campus Life" is vague. Is it intended to mean student clubs, events, and organizations?

**Goal 5**: Certain terms need to be better defined, such as "exercise agency" and "civic mindset."

**Goal 6**: Some strategies are too qualitative. We need to develop strategies to measure success.
