- happened in the quad during a school day. A group of men had large images of underdeveloped fetuses on posters.
 - i. Students felt targeted when seeing the horrific images.
 - ii. Pika Fabiun, staff at Skyline College, would like to create a forum and discuss about this experience.
 - Staff members are doing consultation with the district to figure out rights of the students and campus.
