The President's Council, a group of community members, dedicates their efforts to raising money for Skyline College to serve Skyline College students. The fund raising effort of the council is the President's Breakfast. The funds raised are for the President's Innovation Fund and for Promise Scholarships.

President's Innovation Fund:

Each year, faculty and staff submit request to use the funds to try out an innovative idea for a program of service for Skyline College students. Typically, the programs and services become institutionalized and the college takes on the funding of the effort. Examples of the type of programs started with President's Innovation Funds (PIF) include:

- 1. Hermanas/Hermanos serves Latina/Latino students who typically might not have considered college as an option.
- 5. Skyline Stars A Transfer Student Hall of Fame
- 6. Multicultural Hip Hop Conference resulted in the annual Rock the School Bells Event
- 7. Heart Wrenchers Increasing women participating in Automotive Technology
- 8. Multiple Musical, drama and film productions and showcases
- 9. Youth Entrepreneurship Program supporting youth options for entrepreneurship as a career goal This request will be underwriting the cost of the President's Breakfast event that raises money for programs and services such as the ones listed above. All of the programs and services are directed at serving students.

Promise Scholarships:

The Promise scholarships support the scholarship portion of the Promise Scholars Program, which provides incoming full-time students with comprehensive support that includes a full scholarship for one year, academic support, dedicated counseling, and career and professional development. The program is open to recent High School graduates, or students who have recently completed their GED or adult continuation program. Funds raised at this year's breakfast will support the 500 promise scholars who will enter college in Fall 2018.

Describe purpose and desired outcomes of event or distribution/use of product

The President's Council, a group of community members, dedicates their efforts to raising money for Skyline College to serve Skyline College students. The big fundraising effort of the council is The President's Breakfast. This event will host 250 people who donate to the college.

The desired outcome of the event is to raise as much money as is possible to support the Promise Scholarships and President's Innovation Fund projects. Last year we have raised just over \$200,000. This year we are striving for \$250,000.

There is one consultant, Cindy Abbott, hired by the President's Council to help solicit sponsorships and to handle the logistics behind putting on the event.

The amount of money raised. The desired outcome of the event is to raise as much money as is possible to support the PIF and the Promise Scholarships. Last year we raised \$200,000. This year we are striving for at least \$250,000.
