  - b. \$6000 is set aside in budget. 7 scholarships currently available:
    - i. 2 ASSC Scholarship: for students with 3.0 GPA, have given time and effort to campus activity \$750 each
    - ii. 1 Graduating Class Scholarship: transfer who has been involved in campus community \$500
    - iii. 1 Leadership and Community Service: students transferring into Skyline and active in extracurricular activities - \$750
    - iv. 1 Leadership Scholarship: GPA 2.0 better, participate in club and volunteerism \$750
    - v. 2 Veterans Scholarship: must be student body member of armed forces, priority given for those in Veterans Club. \$500 each
  - c. \$30000 left in advanced budget that we could move for scholarships
  - d. To create a new scholarship we need description of who the scholarship is for and the criteria.
  - e. Study abroad will come to ask for scholarship budget
  - f. Finalized scholarship offered is 22 with a total of \$15000
    - i. 2 ASSC Scholarship: for students with 3.0 GPA \$750 each
    - ii. 3 Graduating Class Scholarship: for students who will transfer to a four year institution, and who has been involved in campus community - \$500 each
    - iii. 2 Leadership and Community Service: students transferring into Skyline and active in extracurricular activities - \$750 each
    - iv. 2 Leadership Scholarship: GPA 2.0 better, participate in club and volunteerism \$750 each
    - v. 3 Veterans Scholarship: must be student body member of armed forces, priority given for those in Veterans Club. \$500 each

- vi. 6 Undocumented Students Scholarship: must be an undocumented student enrolled at Skyline College \$750 each
- vii. 4 International Students Scholarship: must be an international student enrolled at Skyline College, must be in compliance with the requirements set by Fed \$750 each
